<p>Section 1 (15 points)</p> <p>The applicant, or each applicant of a partnership, must be a member(s) of good standing with a clean record in the National body, at region level and at specialist club level.</p> <p>Any member or any member of a partnership who, during their years as member(s) was found guilty of any misdemeanors, including expulsions, within the SAFPA framework, irrespective of the magnitude, shall not be considered in any way to program achieve the allocated points and shall also immediately be disqualified from this award.</p>	<p>Geen tugsake of verhore of skorsing was van toepassing sedert 1977 nie en 'n skoon rekord bestaan.</p>	15
<p>Section 2 (25 points)</p> <p>The member must have served at least 10 (ten) years on the Executive Committee and/or 15 (fifteen) years at regional level, concurrently or separately. This makes up a total of a 25 (twenty-five) year term. Every year longer than 10 (ten) years at the executive level will be accredited as 2 (two) years at the regional level. In the case of a partnership, the total years served by all the members within the partnership should be at least 1½ times that of the above.</p> <p><u>Calculation of Points</u></p> <p>Regional representatives serving on the Executive will receive the same credits as a National Executive member.</p> <p>Regional representative posts which qualify, are the following: President, Vice President, Secretary, Treasurer, Judges Official, Show Manager or Show secretary and Representative.</p> <p>Allocation of points will occur under the following sections:</p> <ol style="list-style-type: none">1. National Executive Committee posts: 1 point for each year served - Max 10 Points2. Regional Committee posts: 1/2 a point for each year served - max 15 points.3. Section 3 (50 points)

Adequate proof of events and motivation must be supplied in the following fields where achievements have occurred:

- 1. Administration** - this pertains to a person's dedication and willingness to help within their specialist club, region or the executive; this applies also to each individual member of a partnership. This point refers to, but is not limited to the following in the pigeon hobby: organizing shows, pigeon days, serving on committees, etc. In case of a partnership at least one member should excel under this criteria - **11 points**
- 2. Judging** on shows in a variety of breeds, and managing pigeon standards, i.e., writing, reviewing and translating. In the case of a partnership, at least one member of the partnership should excel under these criteria - **7 points**
- 3. Attendance** of a broad spectrum of specialist, region & national shows, and not just local regional shows. In the case of a partnership, each member will be judged on attendance in the above criteria. - **6 points**
- 4. Achievements** on shows as a breeder and exhibitor are it on individual basis or in a partnership. (These must be specified). This also refers to names and examples of assistance given to other breeders (be it by way of quality birds provided to the breeder), educational articles in the national pigeon magazine or any other outside magazine or a specialist club magazine, etc. Further points of consideration are providing help to other fanciers by classing their pigeons for show or breeding purposes for the betterment of various breeds. - **10 points**
- 5. Marketing** - the extent to which the individual member or each member of a partnership advertised the Fancy Pigeon hobby by way of marketing and gaining new members - **6 Points**
- 6. General leadership and organization in the hobby** - this includes organization of shows, pigeon days be it within the region, specialist club or on national level within the framework of SAFPA. Specifics in this area for each member in question are creativity, leadership skills and the ability to pull fellow members together as a unit which SAFPA can be proud of - **10 points**

Section 4 (10 Points)

Obtaining national colours are important. An individual member, or two members of a partnership, should at least have 1 (one) scroll in national colours in Administration, Breeding or Judging before any application can be considered for the Hall of Fame Award.

Take in consideration the guidelines for National colours which are as follows:

a. Administration -

The applicant(s) must have served for 12 (twelve) years on a regional committee or the applicant must have served 6 (six) years on the National Executive Committee.

This also includes a combination of the two, in the ratio of 2:1.

b. Breeder -

This includes 12 (twelve) awards in the top seven champions on regional shows or 6 (six) awards in the top seven champions at the National Show. The birds should be bred by the applicant(s). This also includes a combination of the two, in the ratio of 2:1.

c. Judging -

The applicant(s) must have independently judged more than 1 (one) breed at 24 (twenty-four) regional shows or 6 (six) national shows. This also includes a combination of the two, in the ratio of 4:1.

NOTE – The following allocation must be followed under these criteria:

10 Points - All three colours for the individual member or at least 5 colours for the partnership as a group.

6 Points - Two colours for the individual member or at least 4 colours for the partnership as a group.

2 Points - One colour for the individual member or at least 2 colours for the partnership as a group.

0 Points - Zero national colours for the individual or zero colours for the partnership partnership as a group.
